MEMORANDUM OF AGREEMENT

between the

RICHMOND PUBLIC LIBRARY BOARD (hereinafter called "the Employer")

and the

CANADIAN UNION OF PUBLIC EMPLOYEES, LOCAL 718-05 (hereinafter called "the Union")

THE UNDERSIGNED BARGAINING REPRESENTATIVES, ACTING ON BEHALF OF THE <u>RICHMOND PUBLIC</u> LIBRARY BOARD, AGREE TO RECOMMEND TO THE RICHMOND PUBLIC LIBRARY BOARD;

AND

THE UNDERSIGNED BARGAINING REPRESENTATIVES, ACTING ON BEHALF OF THE <u>CANADIAN UNION OF</u> <u>PUBLIC EMPLOYEES, LOCAL 718-05</u>, AGREE TO RECOMMEND TO THE UNION MEMBERSHIP;

THAT THEIR COLLECTIVE AGREEMENT <u>COMMENCING 2022 JANUARY 01 AND EXPIRING 2023 DECEMBER</u> <u>31</u> (hereinafter the "New Collective Agreement") SHALL CONSIST OF THE FOLLOWING:

1. Previous Conditions

All of the terms of the 2020-2021 Collective Agreement continue except as specifically varied below.

2. Term of Agreement

The term of the New Collective Agreement shall be for two (2) years from 2022 January 01 to 2023 December 31, both dates inclusive. Subsections (2) and (3) of Section 50 of the Labour Relations Code shall be specifically excluded from and shall not apply to the New Collective Agreement.

3. General Wage Increase

The Employer and the Union agree that the New Collective Agreement shall reflect wage adjustments as follows:

(a) Effective 2022 January 01, all hourly rates of pay that were in effect on 2021 December 31 shall be increased by two and one-half percent (2.50%). The new hourly rates shall be rounded to the nearest whole cent.

- (b) Effective 2023 January 01, all hourly rates of pay that were in effect on 2022 December 31 shall be increased by two and one-half percent (2.50%). The new hourly rates shall be rounded to the nearest whole cent.
- (c) Retroactive payments will be made as soon as possible following the date of ratification of the Memorandum of Agreement.

4. <u>Housekeeping</u>

Effective the date of ratification of the Memorandum of Agreement, the Employer and the Union agree to make the following amendments:

- (a) delete expired effective dates; and
- (b) any changes mutually agreed to between the parties during the drafting of the new Collective Agreement.

5. <u>Drafting of New Collective Agreement</u>

The Employer and the Union agree that in all instances where an amendment to the Collective Agreement is effective on a specific date, only the amendment shall appear in the new Collective Agreement together with a sentence referencing its effective date.

6. Ratification

The parties expressly agree that, upon the completed signing of this Memorandum of Agreement, the parties shall recommend the approval of this Memorandum to their respective principals and schedule the necessary meetings to ensure that their principals vote on the recommendations not later than thirty (30) calendar days from the date on which the Memorandum of Agreement is signed.
