The LT will engage in a facilitated process that will include, but not be limited to, the exploration and attainment of initiatives to solidify their positions in industry, grow and retain a profitable market share with sustainable qualified employment.

The Parties will fund the Project on a cost sharing basis to be decided between the Transportation Infrastructure Group and the Tripac Unions.

The Project is anticipated to have an initial phase up to the 1st Quarter of 2017. The LT may extend the initial project or add additional phases.
